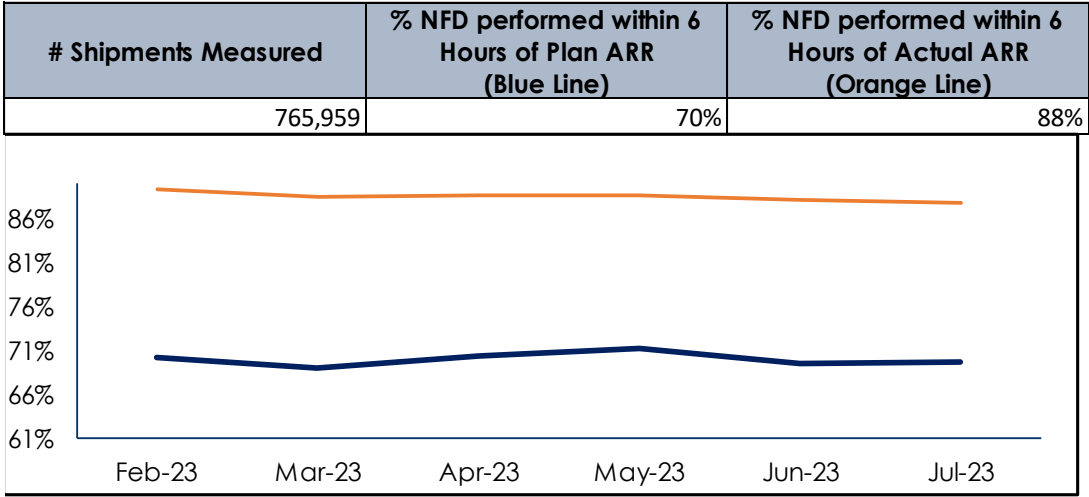

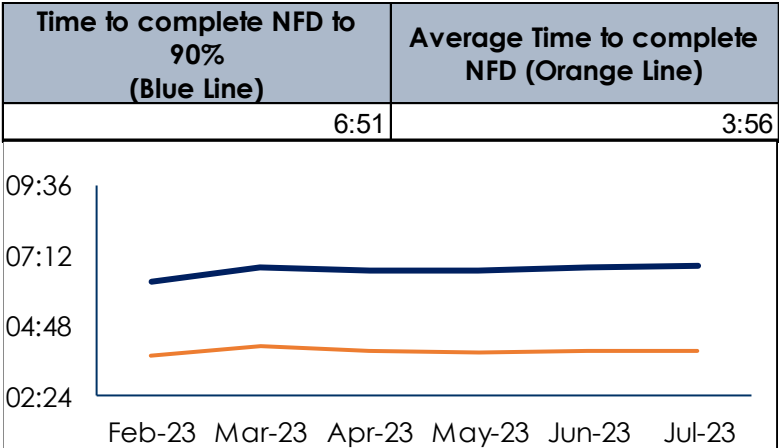
## Import Performance

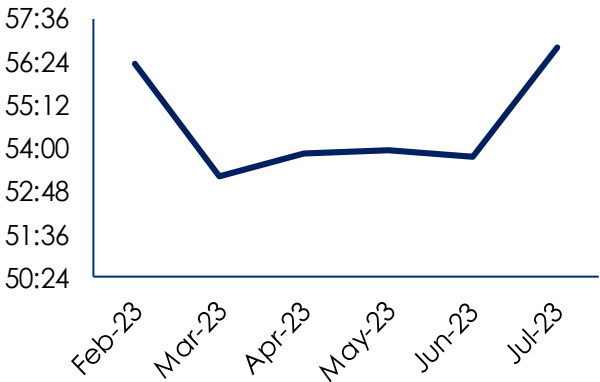
### Average Time To Complete (%) NFD
